- Secretary – Steve
 - Karl Hess provided information on heat stroke/exhaustion which was forwarded to members in an email. Members need to familiarize themselves with the differences.
 - Rosters were validated with the managers.
- Treasurer – Phil
 - One CD, with a current balance of \$20,887, is maturing June 8 and will be rolled over. Possible interest rates are 3.75 and 3.93.
 - This year we have \$23,155 in income and \$16,354 in expenses.
 - The total balance in our accounts, which include two CDs, checking, and money market, is \$37,224.
